

## TERMS AND CONDITIONS

**THIS ONEMEDIFUND WELLNESS PORTAL IS PROVIDED TO YOU BY HOME SUPPORT SERVICES PTY LTD (HSS) WHO HAS CONTRACTED WITH MEDIKEEPER INC., WHO ARE MANAGING AND OPERATING THIS PORTAL ON BEHALF OF ONEMEDIFUND THESE TERMS AND CONDITIONS APPLY TO MEDIKEEPER, HSS, AND YOU AS THE USER.**

### 1. **MediKeeper's Service.**

MediKeeper provides employee and member portals to employers, health plans and wellness companies so that they may provide their employees or members with online health and wellness portals. As an eligible employee or member (hereinafter referred to as a "user"), you will have access to various health and wellness tools such as a Health Assessment, My Tracker, Plan For Wellness and other applications that *onemedifund* has chosen to make available to you. The *onemedifund* Wellness Portal allows you to store, view, edit, retrieve, and manage your personal health information. The service is internet-based and allows you to have access to your personal health records anywhere, anytime. MediKeeper is committed to the highest levels of security and privacy.

### 2. **Availability of *onemedifund* Wellness Portal**

The *onemedifund* Wellness Portal will be available to you for as long as HSS maintains a business relationship with MediKeeper and *onemedifund* maintain a business relationship with HSS. If any party terminates the business relationship with another for any reason, you will no longer have access to the portal or the information contained within it.

You agree that MediKeeper may modify or discontinue the provision of the *onemedifund* Wellness Portal with or without notice to you. You agree that MediKeeper, Inc. will not be liable to you or any third party as a result of such modification or discontinuation.

### 3. **Obligations of the User.**

MediKeeper, HSS and *onemedifund* would like to make you aware of the following information and your obligations:

- While MediKeeper makes every effort to ensure that the medical information and references used within the *onemedifund* Wellness Portal is correct and up to date, the *onemedifund* Wellness Portal does not offer medical advice and is not intended to replace the advice you receive from your own doctor. If you have any questions or concerns about the information contained within the *onemedifund* Wellness Portal you should consult your doctor.
- The performance and loading times of the *onemedifund* Wellness Portal is dependent upon many things that are not in the control of MediKeeper, HSS or *onemedifund* including your own network performance, the age and

performance of your PC, laptop, tablet or mobile device, your browser choice, and the availability of internet connectivity.

- MediKeeper is not responsible for supplying any of the equipment or networks required to receive the *onemedifund* Wellness Portal . This remains the responsibility of the user and/or *onemedifund*.
- The information you provide and enter into the *onemedifund* Wellness Portal or that may be imported into the *onemedifund* Wellness Portal from approved and authorized third parties may contain sensitive and personal health information. You should always logout of the *onemedifund* Wellness Portal after each session to prevent unauthorised persons gaining access to your information.
- When you register as a user for the *onemedifund* Wellness Portal you will be asked to provide a user name and password, which you will then use to login each time you wish to view the *onemedifund* Wellness Portal. It is important that you protect the access to your personal health information by not sharing your user name and password with anyone, and do not write this information down in a place where someone may easily find it. MediKeeper cannot, and will not be liable for any loss or damage arising from your failure to comply with this requirement.
- You agree to immediately notify MediKeeper of any unauthorised use of your password or account or any other breach of security.
- You are responsible for the accuracy of the information you enter into the *onemedifund* Wellness Portal. If you enter incorrect information, deliberately or by accident, you may compromise the accuracy of the results and information you may view in the *onemedifund* Wellness Portal.
- You are responsible for keeping the information within the *onemedifund* Wellness Portal up to date. Some of your results and information are related to dates and times, and for the results to be meaningful, it is important that they are calculated based upon the most up to date information.

#### 4. **Privacy Policy.**

MediKeeper does not provide any information to *onemedifund* about any individual or their personal health information. However, MediKeeper does provide *onemedifund* with de-identified and aggregated reports that show the health of the overall population. Although this information contains nothing that can identify the information as belonging to any one individual, the *onemedifund* Wellness Portal does provide administrators of *onemedifund* with the ability to send targeted messages to groups and individuals who meet certain criteria or health conditions. The administrator will never know the identity of the people to whom these messages are sent.

Only you are authorized to make your personal health information available to others. You can provide access to a family member, a caregiver or a doctor through the "Sharing and Permissions" function within the *onemedifund* Wellness Portal .

You will also be asked to give your permission to access your information in the *onemedifund* Wellness Portal to Coaches from Coaching Companies who may have been contracted by *onemedifund* Wellness Portal to provide you with coaching services. This may be a requirement for you to have access to such coaching services.

**5. User Account, Password and Security.**

You will enter a username and password when completing the registration for the *onemedifund* Wellness Portal . You are responsible for maintaining the confidentiality of the password and account, and are fully responsible for all activities that occur under your password or account.

You acknowledge that information contained within the *onemedifund* Wellness Portal will be transmitted over local exchange, interexchange and Internet backbone carrier lines and through routers, switches and other devices, all of which are beyond the control and jurisdiction of MediKeeper.
